It is hereby between the Chongqing Jiaotong University, hereinafter referred to as the First Party and the KNU, hereinafter referred to as the Second Party, that the two parties shall work together to encourage academic cooperation through joint research, learning and teaching initiatives under the following terms and conditions.

**ARTICLE 1**

**The Scope of Memorandum**

The scope of academic exchange and cooperation covered by this Memorandum include the following:

1. Expanding opportunities for conducting joint and /or collaborative research
2. Exploring opportunities for exchanging students and faculty on a reciprocal basis
3. Exploring opportunities for organizing academic meetings, symposia or workshops
4. Exploring opportunities for organizing academic meetings, symposia or workshops
5. Exploring opportunities for publishing the results of the joint research projects and teaching programs

**ARTICLE 2**

**Organization and Financial Arrangement**

The terms of cooperation, including the financial contribution from each party, for each specific activity implemented under this Memorandum of Understanding, will be mutually discussed and agreed upon in writing prior to the implementation of the particular activity.

Once specific activities have been agreed:

1. A working group may be formed with participants from both parties to manage joint activities of the two institutions.
2. Both parties may be responsible for providing technical, managerial and financial support for joint research programs.

**ARTICLE 3**

**Duration of Activities**

All activities covered under this Memorandum shall be carried out for a period of three years starting from the date on which this agreement comes into effect upon the latest signature. This agreement can be extended upon approval of both parties. In case of termination, a party must give the other party 6 months written notice of its intention to terminate unless an earlier termination date is mutually agreed upon.

In the event that this agreement is terminated by any party giving six months' notice, both institutions agree to honor the terms of the agreement for any students who may have been admitted, or are enrolled on any part of their programmes at the date on which notice is given. In addition, both parties will fulfill any institutional obligations undertaken in relation to staff from their institution.
